A Brief Explanation

Variation of Enrolment Policy - Semester Length Units

Commencement Date: the starting date of each semester.

Administrative Date: (two weeks after Commencement Date). From the Commencement Date until the Administrative Date you may vary your enrolment without any penalty.

After the Administrative date and before the Census Date, for any variation of enrolment, there will be a financial penalty, known as a Variation of Enrolment Fee, but there will be no academic penalty.

All NON FEE-HELP Fees are due by the Administrative date. A further 25% will be added to your fees if not paid by this Date.

Variation of Enrolment Fee for 2008:

Add/Substitute Unit (Enrol Late) after Administrative Date and before Census Date \$30/unit

Withdraw from unit after Administrative Date and before Census Date \$30/unit

The ACT has asked us to charge \$100 and \$300 respectively, but the PTC has agreed to charge only the above fees.

Census Date: (31 March or 31 August) After the Census Date, no Variation of Enrolment Fee applies, but there is no refund of fees and your FEE-HELP liability remains.

Withdrawal Date: (two weeks after Census Date) There is no Variation of Enrolment Fee, but you be given an Academic penalty (unit graded FW) and no refund of fees.
