3. Major Research Project

The major research project is designed to help you engage critically with some of the extra-biblical sources that illuminate our study of the Gospels. The project need not be presented in traditional essay format, and may include diagrams, maps and photographs, where relevant. The project must, nevertheless, engage critically with both the primary ancient sources and modern analysis of those sources. All sources must be recognised in the usual way using footnotes and a bibliography.

1. *Compare and contrast the presentation of Pontius Pilate in the gospels with the presentation of Pilate in other ancient sources (literary, epigraphic, numismatic). How do the extra-biblical sources for Pilate aid our interpretation of the Gospels?*
2. *To what extent does an understanding of first century Jewish revolutionary movements illuminate Christian reading of the Gospels?*

4. *How does an appreciation of the political agenda of the Herods illuminate Christian reading of the Gospels?*
